# CLCA Committee Reports August, 2018

Lake Management: Mary Jablonski, Vice President

Environment and Ecology: Dave Graves, Chair: Last summer, the Environment & Ecology Committee of the CLCA, roughed out a draft committee position on water level fluctuation and erosion. Since that time much has happened, including a revised plan for the dam rehabilitation that did not include level control at the dam, as originally called for in the 2006 Ferris Lake Wild Forest Draft Unit Management Plan. The lack of automatic level control at the dam is a significant step backwards in minimizing the frequency and severity of future highwater events on the lake. A subgroup of our committee (myself, Allen Farber, and James Hays) redrafted our committee position based on our updated understanding of the current situation. The full committee was asked to vote on the updated position statement for forwarding to CLCA President, Chris Rohrs, to help him in his discussions with the DEC. Nine members voted strongly in favor. One committee member was not reachable. Three members abstained, pending additional information on DEC plans for the dam rehabilitation. There were no votes against.

# **Environment & Ecology Committee position statement on flooding and erosion:**

Erosion is a one-way process; once eroded portions of shorelines and marshes cannot be replaced. In human terms this erosion is slow and may be imperceptible to some residents of the Canada Lakes, but long-time residents have observed dramatic reductions in the marshes and wetlands over the years. USGS Survey maps from 1943 and 1997 clearly document that significant areas of marshlands around Lily Lake and West are now mostly destroyed. These remaining wetlands are critical for maintaining the ecological health and diversity of the Canada Lakes ecosystem. Flooding threatens loon nesting habitat, compromises septic systems, and leads to contamination from shoreline erosion.

The Canada Lakes Conservation Association's Environment and Ecology Committee is very concerned that high water events and water level fluctuations will become increasingly frequent. Since 1986 when 1543.1 was established as the "normal" summer water level and 1990 when the last renovation of the dam was completed, there have been significant changes both locally and globally that have made it more difficult to avoid flooding events:

- 1. Removal of the Irving Pond Dam in 1996 eliminated a significant buffer for the roughly 25% of the watershed feeding the Canada Lakes system.
- 2. The reconstruction of the Pine Lake dam in 2007 resulted in a redesign that is extremely effective at maintaining Pine Lake at a constant level by immediately draining from the lake the roughly 40% of the watershed that feeds Canada Lake. Frequent washouts of the West Lake road and culverts due to intense flows from Pine Lake provide evidence of the problem.
- 3. National and State agencies report unequivocally that the intensity and frequency of major rainstorms is increasing in our region. In 2006, 2010, and 2017 Canada Lakes

experienced "100 year" flooding events, with waters rising over 22" above the "normal" summer level.

For these reasons the Environment and Ecology Committee recommends that the CLCA work with the DEC to target a lower water level than the current 1543.1. We understand that an automatic level control has been dropped from the 2018 design specifications for the Stewarts Landing dam rebuild. While we hope to maintain good communication to help address proactively significant flooding threats, we also understand that the DEC wants natural flow and minimal manual manipulation of the dam. We also understand the challenge caused by the length and configuration of the channel between Canada Lake and the dam, for by the time the water level has risen an inch at the dam it will have risen many times that at Canada Lake.

A solution that will increase the buffering capacity of the lake system, help mitigate the harmful effects of intense rain events and minimize the management challenges faced by DEC, is to reduce the height of the flashboards on the dam. We also would like to support the state in better marking the rocks in the channel between Canada Lake and Stewart's Landing that present hazards in both low and high-water times.

Marcus sent an attachment to all Lake Inspectors, with information on how to <u>visually monitor</u> the Wooly Adelgid infestation from boats. This might be a way to help protect the spread of this invasive pest in the Canada Lakes area since most of the shoreline hemlock growth is visible by boat. The Wooly Adelgid information was provided to me by Zach Simek. He is the Terrestrial Invasive Species Coordinator for the APIPP. Mark Whitmore, from Cornell, provided a very eye-opening presentation on this pest at the July CLCA Annual Meeting. The effects on the abundant hemlock population in our area could potentially be devastating. An Invasive Species Committee Meeting is scheduled for September 1<sup>st</sup> at 9:00 am at the Town

Hall.

The tower and connecting trail system is getting a lot of use. There is very little litter, and it is in great shape, overall.

**Island:** Rick Fink, Chair: The results of the July 21, 2018 fire drill with non-road access Lake residents and the Caroga Lake Volunteer Fire Department, is reported in the CLCA Newsletter of August 3-9. It was a well-attended and successful event.

Adirondack: Jim Hays, Chair: Chris Rohrs and I attended the Adirondack Lake Alliance meeting at Paul Smith's earlier in the summer. The meeting focused on road salt Pollution. State highways account for most of the salt applied to road surfaces. This salt eventually finds its way 50% into Adirondack surface waters and even more disturbing the other half into ground waters. The large amount of salt applied to state highways is due to the state's effort to keep these highways open to high speed traffic. They did not recommend substitutes for NaCl as all the substitutes also have issues. Rather find ways to reduce the amount of salt used.
