Dear Mr. Monroe:

The water level in Canada, Green and West Lakes as regulated by the dam at Stewart's Landing is of continuing interest to the camp owners on the shores of these lakes. The Board of Directors and the Water Level Committee of the CLPA wishes to affirm that the 1978 accord which sets the summer level at 1542.8 ft, the winter level at 1536.4 ft and with the level being dropped to 1540.8 on Oct. 1 continues to satisfy the needs of most of the members of the association.

While we understand that the water level cannot be controlled precisely, large temporary excursions above the fall level of 1540.8 feet have been observed in recent years. These unanticipated increases in water level, which did not appear to be attributal to rainfall, were disruptive to dock and boathouse maintenance that was underway, and we hope that such occasions will be infrequent.



Thank you for your letter of September 17, 1981 reaffirming the 1978 accord between the Association and our Department establishing the former water level in Canada, Green and West Lakes at 1542.8 feet and the winter level at 1536.4 feet with the level dropped to 1540.8 feet on October 1.

By copy of this letter, I am informing William Krichbaum, Regional Operations Supervisor, under whose direction the dam is regulated at Stewart's Landing, to check with his person in charge about the temporary excursions above the fall level of 1540.8 feet referred to in your letter. It is agreed these excursions may be disruptive to dock and boathouse maintenance and should be restricted to those occasions attributable to rainfall beyond our control.
